I. Course Description

This course focuses on Chinese international economic cooperation in the past more than three decades (1980-2017). With rich materials and vivid pictures, it will analyze Chinese international economic cooperation since her reform and open policy was applied.

The course consists of two parts: (1) General economic cooperation, such as Chinese foreign trade, FDI inflow, investment abroad, FTAs (free trade agreements), etc; (2) Specific economic cooperation between China and different countries/regions, especially China-USA, China-EU, China-Japan, China-ASEAN, and so on.

II. Course goals and outcomes

The course aims to introduce students to the Chinese international economic cooperation since China applied her reform and open policy in 1978.

The course will help students understand more deeply about Chinese general economic cooperation and specific economic cooperation with different countries/regions.

III. Class Policies
