The great consumer boom. OPEC and oil prices. The World Bank and IMF. The EU and other economic regionalisms. World poverty. New political movements: civil rights, feminism, fundamentalism, ethnic conflicts and nationalism.

- (i) To give students an overview of the main developments in the World history during the period covered.
- (ii) To increase students' awareness of the nature of historical thinking and methodology.
